





## **Background:**

India Produces about 2.0 million tones of Castor seed, meets more than 90% of World's demand of Castor Oil thereby enjoying dominant position in the World Castor Scenario. India's exports of Castor oil and derivatives are estimated above INR 10,000 crores (US\$ 1.4 Billion) per annum. The Global Castor derivatives market estimates to be over US\$4.00 Billion is highly dependent on India.

World Castor Sustainability Forum (WCSF) facilitates the development of a sustainable and traceable supply chain of castor while improving the economic, social, and environmental performance of the castor supply chain. # **Objectives:**

In the last 7 years, more than 30,000 castor farmers are trained on GAPs and Sustainable practices. The average productivity in model farms has increased and is 50 % higher than that of non-project farmers year on year. From 68 model farms in the year 2016-17 to 600 model farms in the year 2023-24. The project has a ripple effect on even non-project farmers as they started adopting the project's best practices, thereby enhancing their productivity and overall production of castor seed in the country.
